Small businesses to include foster care, day care, rest home, family care homes, nursing homes, and other health care facilities:

Permit to review up to 10,000 sq. ft. \$75.00

Large businesses and sprinkler systems; permit, plan review, and first inspection:

10,001 to 25,000 sq. ft. \$125.00

25,001 to 100,000 sq. ft. \$175.00

Over 100,001 sq. ft. \$300.00

**SPECIAL USER PERMITS:**

Food Trucks \$75.00

Churches \$50.00

Fireworks for public display \$50.00

Tents greater than 700 square ft. and any Air Structure (30 days permit) \$50.00

Temporary kiosks or displays for merchandising \$50.00

Insecticide fogging fumigation \$50.00

Explosive materials (Blasting Permit) \$50.00

Special Assembly (gun shows, craft shows, etc) \$50.00

ALE Permit \$100.00

Any other special function requiring fire inspection or approval \$50.00

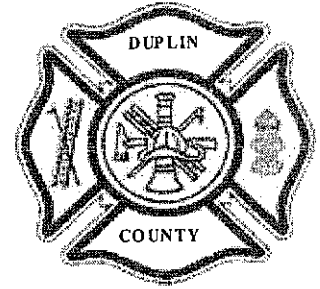
